## 1 – RULES FOR PRESS ACCREDITATION

Acceptance of the application for accreditation is subject to the endorsement of the event organiser. Each request will be checked to ensure that the conditions for accreditation are met and, where applicable, will be subject to the supervision of the competent National Sporting Federation, Eurosport and the FIA.

For organisational and security reasons, each media outlet may accredit a maximum of 2 correspondents, whether photographers, journalists or video operators. Each accreditation form is valid for one person only.

Press accreditation is only issued to persons over 18 years of age. The pass is strictly personal and any abuse will be reported to the judicial authorities.

## 2 – DECLARATION OF LIABILITY

The undersigned declares that he/she is aware of the dangers that may exist in the context of motor racing events and in witnessing them along the race track. He also declares that he has the experience and professional training to assist in the safe running of events and to take all necessary precautions to avoid physical and material damage. It undertakes to comply with the safety orders given by the UDG and the Police Force on duty. It assumes all responsibility for any damage it may suffer as a result of its own carelessness or inexperience. To relieve the Organising Committee, the Clerk of the Course and any other person, Institution or Association from any and all civil and criminal liability in respect of the above. Finally, he/she undertakes to comply with any provisions relating to the use and validity of the pass that may be communicated during accreditation.
